The Data Resource Center for Child and Adolescent Health (DRC), a project of the Child and Adolescent Health Measurement Initiative (CAHMI), aims to provide essential maternal and child health data at the national, state and community level in order to inform and enhance maternal and child health policy and practice. The DRC maintains a website providing user-friendly,

point-and-click access to national, state, and regional data findings from two large parent or family reported surveys on child and adolescent health and well-being in the US, Health Resources Services Administration's (HRSA's) MCHB National Survey of Children's Health and National Survey of Children with Special Health Care Needs.

What surveys are available on the DRC?

The National Survey of Children's Health (NSCH):

The NSCH is the prime focus of the DRC and funded and directed by the Health Resources and Services Administration (HRSA) Maternal and Child Health Bureau (MCHB). The NSCH provides rich data on multiple, intersecting aspects of children's lives – including physical and mental health, access to quality health care, and the child's family, neighborhood, school and social context. The NSCH is administered annually as of 2016 as a mail or web-based survey by the Census Bureau.

Data from previous survey years are also available, from when this survey was administered every four years (2003, 2007, 2011/12). The NSCH was sponsored and directed by HRSA MCHB and conducted by the National Center for Health Statistics at the Centers for Disease Control during these years.

The National Survey of Children with Special Health Care Needs (NS-CSHCN):

The NS-CSHCN was administered in 2001, 2005/6, and 2009/10. In 2016, content from the NS-CSHCN and the NSCH were combined into a single survey for annual administration.

- **Data Sets and Codebooks:** Access coded survey data sets in SPSS, SAS and STATA formats as well as SPSS and SAS codebooks at no cost. These data sets include all records and variables found in the Census Bureau public use data file as well as constructed NPMs, NOMs and variables corresponding to measures of children's health status, health care quality and system performance, family, school, and neighborhood characteristics featured in the DRC online data query.
- **National, regional, and state-level snapshots:** Compare state level data through hotspotting tables and US maps for Title V National Outcome and Performance Measures.
- **Resources to use and understand your data:** Find information on survey methodology, survey instruments, information on survey changes across the years, as well as presentations, reports, chartbooks, and peer-reviewed publications using data displayed on the DRC.
